
Presidential News

Thank you all so much for the life-changing work you do every day for your students and clients. It is a beautiful day to thrive in North Dakota!





NDSCA Summer Update

Despite COVID, it was a successful year for NDSCA. We were able to maintain our PD offerings with the pre-conference and a Spring Conference (in place of the fall conference) via virtual means. We had a total of 109 register for the pre-conference and about 90 of those attended the live sessions. The spring conference had 36 registrants (2 that did not attend the pre-conference) and about 22 attended live. CEU's were offered for both events. We did find some conference sponsors this year and believe some of these new connections will continue to support our association in the future.

A venue change for future pre-conference events is in the works due to a yearly Bismarck School related event that takes place the 2nd Saturday of each month at the Career Academy.

We developed a new strategic plan, created subcommittees to focus on initial priorities determined by the board and progress has been made by all four subcommittees. A t-shirt/merchandise store is going to go live very soon as a fundraiser for our student scholarship program. A link will be sent out via the NDSCA listserv once it is ready. We had several members, including myself and Becky Meidinger, testify before a legislative committee regarding HB 1013 which impacts school counseling in our state. The proposed Bill added an elementary school counselor mandate and attempted to define appropriate and inappropriate school counseling duties. The Bill did end up passing the elementary mandate to begin the 2022-2023 school year, but the defining of duties was unfortunately removed. NDSCA is up for by-laws review this year by ASCA, so the necessary paperwork and documents were submitted to ASCA last week.

We will have 5 NDSCA board members and 1 from membership attending the LDI conference in July. Myself, Liz Kappel, Terri Kroll & Angel Lindseth are the board members attending in Vegas. Malarie Carlson, a general member of NDSCA, is also attending in Vegas. Heidi Olson will attend virtually. We are excited to have so many ND counselors attending this leadership conference!




Updates from NDCDA

NDCDA held its spring business meeting during the NDCA virtual conference on February 8, 2021 via Zoom. Business taking place included discussions on setting up virtual regional career development counselor meetings on a consistent day and time each month to allow both new and veteran counselors time to connect on what is going on in their buildings as well as discussions on the upcoming summer book study opportunity through NDCDA. At the meeting, there were also updates from the state career development supervisor Kelly Pierce, CRN coordinator Julie Hersch, NDACTE representative Dustin Martin, NDCA representative Danielle Luebke, and legislative committee chair Allison Orgaard. The end of summer annual ND CTE Professional Development Conference will be taking place in Bismarck at the Bismarck Event Center August 9-11, 2021 and will include sessions focused on career development and many other areas.

Grant money was awarded to NDCDA last fall from the NDCA for use to purchase items for welcome baskets for new counselors and a social at the 2020 PDC conference. Due to COVID-19, the conference was moved to virtual platform so the social did not take place. Grant funds that were going to be used for physical items for gift baskets were used to purchase gift cards to "Teachers Pay Teachers" for new counselors to use for resources their first year. \$170 was spent on 17, \$10 gift cards.

Please remember to check with the state licensure board for any services that you may want to provide to a client that is located outside of North Dakota borders. During the pandemic, many states allowed services from out-of-state providers. However, most states are not returning to pre-pandemic requirements.

Many ethics on-line courses or webinars are being accepted for CEs by the ND Board of Counselor Examiners. Pre-check with the board prior to registering.
