Legislative News

As chair of the Legislative/Education Task Force Committee I would like to take the time to update you on the progress the committee is making in addressing the strategic plan goals. Advocacy is a key issue for counselors in all realms. The goals focus on addressing issues regarding counselors being able to access Medicaid, Medicare, and the VA; while also monitoring educational issues.

The American Counseling Association has been busy advocating on Capitol Hill the importance of counselors being able to access Medicare and the VA, along with education funding. During my time in Washington, DC in July for the Leadership Institute we advocated for three different legislative bills to our state representative and Senators. I would like to highly recommend all counselors contact our state Representative and Senators on supporting

these following bills. Talk to our senators about “Seniors Mental Health Access Improvement Act” regarding Medicare reimbursement, the Elementary and Secondary School Counseling Program, along with opening the doors of the VA to counselors. For your state representatives address the VA, the school counseling program, and HR 2759 for Medicare reimbursements. I have posted on the NDCA website fact sheets about the various programs. The best way to contact your state Representatives and Senators is to email them. All of their emails can be located on the national websites for each individual. It is important for all of us counselors to advocate for the profession. Feel free to contact me for any information on these subjects and how to best advocate on any legislative issues.
